16. At least 10% seats of the School will be kept reserved for meritorious students of Scheduled Caste/Schedule Tribe and no extra fee will be charged more than that is fixed by U.P. Madhyamik Shiksha Parishad/Basic Shiksha Parishad, U.P.

Madhyamik Shiksha Parishad or Basic Shiksha Parishad and if later on, the School is affiliated to Central Board of Secondary Education/Council for the Indian School Certificate Examination, New Delhi, the affiliation of U.P. Madhyamik Shiksha Parishad will automatically be cancelled that year from the date of grant of affiliation by Central Board of Secondary Education/Council for the Indian School Certificate Examination.
18. The pay scales and other allowances to the teaching/non-teaching staff of the School will not be below the scale given to Govt. aided Schools.
19. The Services Rules for the employees of the School will be framed and they will be granted the retirement benefits as applicable to the aided non-Government Higher Secondary Schools.


